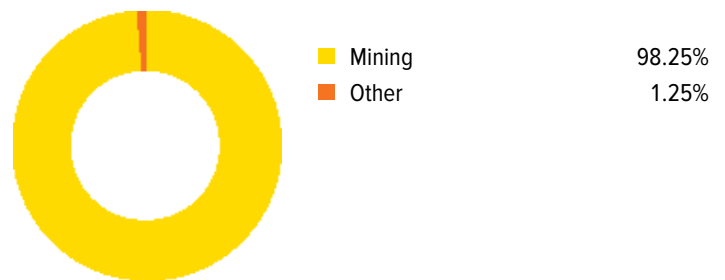

INDEX DESCRIPTION

The U.S. Global Go Gold and Precious Metal Miners Index is composed of exchange-listed common stock (or ADRs of U.S. and international (including emerging markets) companies that can earn at least 50 percent of their aggregate revenue from precious metals through active (i.e., mining or production) or passive (i.e., owning royalties or production streams) means ("Precious Metals Companies"). The U.S. Global Go Gold and Precious Metal Miners Index may include small-, mid-, and large-capitalization companies.

Price-Earnings Ratio (P/E Ratio) is determined by dividing the price of the stock by the company's forecasted earnings per share.
